Requests must be received within thirty (30) days after the conclusion of the Tournament.

1. **ELIGIBILITY.** The Tournament is open only to legal U.S. residents of California who are eighteen (18) years of age or older at the time of registering for the Tournament ("Participant"). Void where prohibited or restricted by law. Employees, contractors, officers and directors of Sponsor, Barnes Tennis Center ("Administrator"), each of their affiliates, parent companies, subsidiaries, divisions, suppliers, distributors and advertising, promotional and judging agencies, the Station, and any third party prize provider(s) and/or prize fulfillment service (collectively, the "Tournament Entities"); individuals employed by any other radio and television station; and members of the immediate families (spouse and biological, adoptive or step-parents, grandparents, children, grandchildren and siblings, and each of their respective spouses regardless of where they reside) or households (whether related or not) of any of the above individuals are not eligible to participate in the Tournament or win the prize. The Tournament is subject to all applicable federal, state, and local law and regulations.

By participating, you agree (a) to be bound by these Official Rules; (b) as between you and the Sponsor, that the decisions of the Administrator are final on all matters relating to the Tournament; (c) you are not participating on behalf of any employer or third party; (d) in the event you do not comply with these Official Rules, you will be disqualified and your prize (if any) will be forfeited; and (e) (when applicable) that you must be available to participate in any portion of the Tournament that participation may be required to be considered eligible.

2. <u>TOURNAMENT OVERVIEW AND PLAY</u>. Participants must pre-register by August 20, 2024, 11:59:59 pm. Pacific Time ("PT") in order to participate in the Tournament. See Section 3 below for registration details. The Tournament will be held on August 24, 2024 at the Barnes Tennis Center (4490 W Point Loma Blvd, San Diego, CA 92107). The start time and match times will be announced and communicated to registered Participants at a date later than the publication of these Official Rules. The Tournament shall be conducted in a "Round Robin" format, in which each team competes against every other team in their Division. The teams with the highest points, shall advance to the Medal Round to determine the winner of each Division. The number of teams participating in the Medal Round shall be determined, by the Administrator, based on the number of teams per Division and final Division breakout, based on registration.

Tournament play is subject to the USA pickleball rules which can be found at usapicklball.org. Any variation of the rules shall be disclosed, by the Administrator, prior to and/or during the Tournament. All games for the Tournament shall be played as doubles (two (2) players per team). In the case where a member of a team is not present at the time of their particular match, that team forfeits their match, at the sole discretion of the Administrator. For Round Robin games: The winning team of each game shall be "the team with the most points at the 15-minute mark" or "the team who first received eleven (11) points or more with a 2-point win". For the Medal Round games: The winning team of each game shall be "the team who first received eleven (11) points or more with a 2-point win". Format may be altered at Administrator's discretion.

Participation Conditions: The Sponsor and Administrator are not responsible for any delay, cancellation or rescheduling of the Tournament. All costs associated with attending and participating in the Tournament, including, but not limited to any transportation to/from the Tournament are the sole responsibility of each Participant. Participant agrees to accept all space availability requirements established by the venue and must comply with all applicable laws, and any rules and regulations established by the venue. Sponsor and Administrator have no responsibility or obligation to any Participant who is unable to attend the Tournament or who is late to the Tournament, for any reason. Sponsor and Administrator

reserve the right to remove or to deny entry to any Participant who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person during the Tournament. At the Tournament, all participants must conduct themselves at all times in a socially responsible, respectful and appropriate manner including following all private guidance from the venue operator. Participant agrees that participating in the Tournament is done so entirely upon their own initiative, risk, and responsibility.

PARTICIPANT UNDERSTANDS AND ACKNOWLEDGES COMPLETELY THAT THERE ARE RISKS INVOLVED IN PARTICIPATING IN A PICKLEBALL TOURNATMENT, INCLUDING THE RISK OF SERIOUS PHYSICAL INJURY OR DEATH. PARTICIPANT SHOULD CONSULT WITH HIS OR HER PHYSICIAN PRIOR TO PARTICIPATING IN THE TOURNAMENT.

3. **REGISTRATION.** Between August 6, 2024 at 12:00:00 a.m. Pacific Time ("PT") and August 20, 2024 at 11:59:59 p.m. PT, visit https://www.barnespickleball.com/IHM ("Website") to register for the Tournament. Participants will be able to choose from one of the following skill-level divisions (each a "Division"): 3.0 Women's Doubles; 3.0 Men's Doubles; 3.5 Women's Doubles; 4.0 Women's Doubles; 4.0 Women's Doubles; 4.5 Women's Doubles; 4.5 Men's Doubles. If the Administrator determines there are not enough Participants for a particular Division (or Divisions), Divisions (levels) may be combined at the sole and absolute discretion of the Administrator.

During the registration process, complete and submit the online registration form with all requested information (including your name, email address, phone number, date of birth, Tournament partner's name and/or any other information requested by the Administrator). Next, submit payment of the registration fee as indicated on the Website. Registration form must contain all information requested and payment must be submitted and accepted for your registration to be confirmed. Limit: A Participant may only participate in one (1) Division.

<u>Registration Fee</u>: Each member of team (each individual Participant) must complete a separate registration form and pay a registration fee of \$50.00 per person. Must register by August 20, 2024, 11:59:59 pm. PT. **ALL REGISTRATION FEES ARE NON-REFUNDABLE.**

The Released Parties (as defined below) are not responsible for lost, late, undeliverable, illegible, stolen, misdirected, mutilated, or incomplete registrations, regardless of cause. Multiple Participants are not permitted to share the same email address. Should multiple users of the same e-mail account or mobile phone number, as applicable, enter the Tournament and a dispute thereafter arise regarding the identity of the Participant, the authorized account holder of said e-mail account or mobile phone account at the time of registration will be considered the Participant. "Authorized account holder" is defined as the natural person who is assigned an e-mail address or mobile phone number by an Internet access provider, online service provider, telephone service provider or other organization which is responsible for assigning e-mail addresses, phone numbers or the domain associated with the submitted e-mail address. Proof of submission of a registration shall not be deemed proof of submission or receipt by the Sponsor for online registrations. Registrations will be disqualified if incomplete and/or if prohibited multiple registrations in excess of the stated limit are received. All submissions become the property of Sponsor and will not be acknowledged or returned.

4. <u>WINNER DETERMINATION</u>. All decisions of the Administrator shall be final in regards to determining the winners in accordance with these Official Rules.

For First Prizes: See Section 2. At the end of the Tournament, the Administrator will have determined the First Prize winners, for each Division, based on the final winner (winning team) of the Medal Round.

For the Grand Prize: The winners of each Medal Round, one (1) team per Division, shall be entered into a random drawing. The random drawing shall be conducted by the Administrator who will randomly select one (1) winning team who will receive the Grand Prize ("Grand Prize Drawing").

Potential winners are subject to verification, including verification of eligibility. Potential winner(s) may be required to present a state authorized identification prior to being awarded a prize and may be required to sign and return an affidavit of eligibility/liability release and publicity release (where lawful) and/or any other form(s) necessary to verify eligibility, claim prize, and agree to all prize conditions within three (3) business days.

by the venue operator, prize provider or any other persons providing any prize-related services. If travel delays, cancellations or difficulty prevent arrival in time for the event, the Sponsor is not responsible for awarding any compensation in lieu thereof. Released Parties are not responsible for: (a) mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, incomplete, garbled or delayed transmission of online registrations, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online Participant's ability to participate in the Tournament; (b) any injury or damage to Participant's or any other person's computer related to or resulting from participating in or downloading any information necessary to register in the Tournament; (c) any incorrect or inaccurate information, whether caused by Participants, printing errors or by any of the equipment or programming associated with or utilized in the Tournament; (d) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (e) unauthorized human intervention in any part of the registration process or operation of the Tournament; or (f) technical or human error which may occur in the administration of the Tournament or the processing of registrations.

This data may be passed to a third party to enable such third party to fulfill any necessary requirements relating to the award of a prize. Any other use of personal data will be in accordance with, and subject to, the Sponsor's Privacy Policy located <u>here</u>. Participant may have the opportunity to opt-in to receive emails from third parties. In the event that Participant opts in to any available opportunities to receive information from a third party, that may or may not be associated with this Tournament, Participant understands and acknowledges that his/her information will be provided to such third party and may be used by the third party as set forth in the third party's privacy policy. **Any available opt-in opportunities are not required to enter the Tournament.**
- RELEASES, CONDITIONS, AND LIMITATIONS OF LIABILITY. By participating in the Tournament, each Participant agrees to release and waive any and all claims of liability against the Tournament Entities and any applicable third party fulfillment service and each of their respective employees and agents (collectively, the "Released Parties") from and against any and all liability, loss or damage (including personal injury) incurred with respect to the conduct of or participation in the Tournament, or the awarding, shipping/handling, receipt, possession, and/or use or misuse of any prize, including any travel related thereto. Persons who violate any rule, gain unfair advantage in participating in the Tournament, or obtain winner status using fraudulent means will be disqualified. The Sponsor will interpret these Official Rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Tournament and the Sponsor's decisions concerning such disputes shall be final. Inclusion in such drawing shall be each Participant's sole and exclusive remedy under such circumstances. Any reference in these Official Rules or as part of the Tournament to the Sponsor's and/or Station's "discretion" and/or any exercise of discretion by the Administrator, Sponsor or Station shall mean in Administrator's, Sponsor's and/or Station's "sole and unfettered discretion." The Sponsor and/or Administrator further reserve the right to terminate the Tournament if in its sole judgment, the rules or the integrity of the Tournament have been violated or compromised in any way, intentionally or unintentionally by any person whether or not a Participant in the Tournament. In the event the Tournament is terminated, no prizes will be awarded. If applicable, material changes to the Official Rules will be made available online at the Website, when practical. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of this provision.
- 12. <u>BINDING ARBITRATION</u>. Any controversy or claim arising out of or relating to the Tournament shall be settled by binding arbitration in a location determined by the arbitrator as set forth herein (provided that such location is reasonably convenient for claimant), or at such other location as may be mutually agreed upon by the parties, in accordance with the procedural rules for commercial disputes set forth in the Comprehensive Arbitration Rules and Procedures of JAMS ("JAMS Rules and Procedures") then prevailing, and judgment upon the award rendered by the arbitrator(s) may be

entered in any court having jurisdiction thereof. The arbitrator shall be selected pursuant to the JAMS Rules and Procedures. The arbitrator shall apply Texas law consistent with the Federal Arbitration Act and applicable statutes of limitations and shall honor claims of privilege recognized at law. In the event that the claimant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, Sponsor will pay as much of the claimant's filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive. If any part of this arbitration provision is deemed to be invalid, unenforceable or illegal (other than that claims will not be arbitrated on a class or representative basis), or otherwise conflicts with the rules and procedures established by JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, the portion that is deemed invalid, unenforceable or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor Sponsor shall be entitled to arbitrate their dispute. Upon filing a demand for arbitration, all parties to such arbitration shall have the right of discovery, which discovery shall be completed within sixty days after the demand for arbitration is made, unless further extended by mutual agreement of the parties.
