18 I, the undersigned, say, on information and belief, that in
19 the County of Yolo, State of California:

20 Count 1 : On or about September 13, 2017, ROBERT WILLIAM
21 HODGES did commit a FELONY, namely, a violation of Section
22 187(a) of the California Penal Code, WILLFUL, DELIBERATE AND
23 PREMEDITATED FIRST DEGREE MURDER, in that ROBERT WILLIAM HODGES
24 did willfully and unlawfully kill a human being, to wit, Lucas
25 Hodges, with malice aforethought.

26 Count 2 : On or about September 13, 2017, ROBERT WILLIAM
27 HODGES did commit a FELONY, namely, a violation of Section
28 187(a) of the California Penal Code, WILLFUL, DELIBERATE AND

1 PREMEDITATED FIRST DEGREE MURDER, in that ROBERT WILLIAM HODGES
2 did willfully and unlawfully kill a human being, to wit, Julie
3 Hodges, with malice aforethought.

4 Count Enhancement 2a : It is further alleged that during
5 the commission or attempted commission of the felony charged
6 above, ROBERT WILLIAM HODGES did willfully, unlawfully, and
7 personally use a deadly or dangerous weapon, within the meaning
8 of Section 12022(b)(1) of the California Penal Code, USE OF
9 DEADLY WEAPON, to wit, a belt.

10 Count Enhancement 2b : It is also alleged that defendant is
11 subject to a SPECIAL CIRCUMSTANCE within the meaning of Section
12 190.2(a)(15) of the California Penal Code in that defendant
13 intentionally killed the victim by means of lying in wait.

14 Count 3 : On or about September 13, 2017, ROBERT WILLIAM
15 HODGES did commit a FELONY, namely, a violation of Section
16 187(a) of the California Penal Code, WILLFUL, DELIBERATE AND
17 PREMEDITATED FIRST DEGREE MURDER, in that ROBERT WILLIAM HODGES
18 did willfully and unlawfully kill a human being, to wit, Kelvin
19 Hodges, with malice aforethought.

20 Count Enhancement 3a : It is further alleged that during
21 the commission or attempted commission of the felony charged
22 above, ROBERT WILLIAM HODGES did willfully, unlawfully, and
23 personally use a deadly or dangerous weapon, within the meaning
24 of Section 12022(b)(1) of the California Penal Code, USE OF
25 DEADLY WEAPON, to wit, a belt.

26 Count Enhancement 3b : It is also alleged that defendant is
27 subject to a SPECIAL CIRCUMSTANCE within the meaning of Section
28 190.2(a)(15) of the California Penal Code in that defendant

1 intentionally killed the victim by means of lying in wait.

2 Count 4 : On or about September 13, 2017, ROBERT WILLIAM
3 HODGES did commit a FELONY, namely, a violation of Sections 21a,
4 664(a) and 187(a) of the California Penal Code, ATTEMPTED
5 MURDER, in that ROBERT WILLIAM HODGES did willfully, unlawfully
6 and with malice aforethought attempt to murder Mai Hodges, a
7 human being.

8 Count Enhancement 4a : It is further alleged that the
9 attempted murder alleged above was willful, deliberate and
10 premeditated within the meaning of California Penal Code Section
11 664(f), ENHANCEMENT FOR WILLFUL, DELIBERATE AND PREMEDITATED
12 ATTEMPTED MURDER.

13 Case Enhancement a : It is also alleged that ROBERT WILLIAM
14 HODGES did commit multiple murders within the meaning of Section
15 190.2(a)(3) of the California Penal Code, SPECIAL CIRCUMSTANCES
16 FOR MULTIPLE MURDERS.

17 I declare under penalty of perjury that the foregoing is
18 correct.
