- FOOD VENDORS NO PROPANE TANKS allowed indoors as per The City of Robstown.
- The iHeartMedia Event Coordinator determines the location of each vendor booth.
- Event set-up and check-in hours are at 10AM on Sunday, May 6, 2018. Vendor booths must be functional NO LATER than 12PM. Vehicles must be moved off vendor area by 9PM that same evening.
- The vendor is responsible for cleaning up the area occupied during event and trash disposal.
- The Undersigned applicant warrants that applicant is solely responsible for what is being distributed. It is understood that iHeartMedia, Inc. as sponsors of the event merely rent the space to the vendor and assumes NO RESPONSIBILITY for the safekeeping or protection of same.
