On the 30 day of December, 2018 at 17:50 (Specifically include facts constituting cause for arrest.)

I responded to the Mar A Lago Club located at 1100 S. Ocean Blvd., in reference to a report of trespass. Upon arrival, I observed a silver 2009 Acura, bearing FL tag L376HL, parked in the service entrance area. I observed a black male, later identified via FL DL # W362-063-87-060-0, as Brian Carsello Whitehurst (B/M, DOB: 2/20/87) standing by the rear of the vehicle. I then spoke with US Secret Service Resident Agent In Charge (RAC) Tim Donohue who stated that Whitehurst arrived on the property in the silver Acura. Donohue explained that Whitehurst stated he was there to see President Trump about his 6.3 trillion dollars, and that he had a reservation to stay at the hotel. RAC Donohue stated that he told Whitehurst he did not have a reservation, and that he would have to leave the location or he would be arrested for trespassing. Whitehurst replied, he was not going to leave, and that he would have to be arrested. Then RAC Donohue, Special Agent Samuel Ivanovich, and Mar A Lago Senior Security Officer on site Anderson Altidor confirmed again that Whitehurst did not have a reservation and that Whitehurst needed to leave the property. In my presence Special Agent Ivanovich told Whitehurst again that he did not have a reservation and that he needed to leave the property or he would be arrested. Whitehurst again stated that he would not leave.

Based on the above facts at approximately 1750 hours, I arrested and charged Whitehurst for Trespass after Warning - Property pursuant to FSS 810.09 (2) (B).
