

Ryan Seacrest's "Becoming" by Michelle Obama Flyaway Sweepstakes
OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY.

1. **PROMOTION ENTRY PERIOD:** Ryan Seacrest's "Becoming" by Michelle Obama Flyaway Sweepstakes (the "Sweepstakes") begins at 12:00:01 a.m. Eastern Time ("ET") on January 21, 2019 and ends at 11:59:59 p.m. ET on January 27, 2019 (the "Sweepstakes End Date") (collectively, the "Promotion Entry Period"). All entries must be received during the Promotion Entry Period. The Sponsor's (as defined below) computer is the official time keeping device for this Sweepstakes.
2. **ELIGIBILITY:** Sweepstakes is open to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are at least eighteen (18) years of age or older as of the date of entry. If a participant has not reached the age of majority in his/her primary state of residence as of the date of entry into the Sweepstakes (which is eighteen (18) years old in most states but is nineteen (19) years old in Alabama and Nebraska and twenty-one (21) years old in Mississippi) (a "Minor"), then the participant must obtain parental consent in order to be eligible to enter the Sweepstakes. Parental consent occurs when the parent or legal guardian of a Minor grants permission for the Minor to participate and agrees on behalf of himself/herself and the Minor to these Official Rules. If you are not a legal resident of the United States or you are not the required age as of the date of entry, you are not eligible to participate in this Sweepstakes or to win a prize. It is strictly prohibited for anyone who does not meet the age requirement as of the date of entry to be allowed to participate in the Sweepstakes and in no situation shall anyone under the age of thirteen (13) be permitted to enter any sweepstakes at any time, under any circumstances. Subject to all applicable federal, state, and local laws and regulations. Void in Alaska, Hawaii, outside of United States, and where prohibited or restricted by law. 3. **HOW TO ENTER:** During the Promotion Entry Period, submit your entry by visiting <http://www.onairwithryan.com> or <http://www.AT40.com> and follow the Sweepstakes link to review the submission guidelines and complete all required information in the online entry form. Entries limited to one (1) entry per person per day (each a "Regular Entry") during the Promotion Entry Period. A "day" begins at 12:00:01 a.m. ET and ends at 11:59:59 p.m. ET.

Bonus Entries:

Upon completion of a Regular entry into the Sweepstakes, participants may also click on the bonus entry buttons to (i) follow the Radio Show on Twitter, (ii) follow the Radio Show on Instagram, and (iii) favorite the Radio Show on your iHeartRadio account (collectively, the "Action(s)"). No social media accounts are required to enter the Sweepstakes, and you do not have to "Like" or "Follow" or "Favorite" in order to gain an entry.

Limit of up to six (6) bonus entries per person throughout the Promotion Entry Period, regardless of the social media entity used. Note that these Actions MUST be done through the bonus entry buttons on the online entry form. If any of these Actions are taken through any other means, you will not receive a bonus entry for that Action.

Regular Entries and bonus entries together shall herein be referred to as "Entries". All eligible Entries must be received during the Promotion Entry Period to be eligible.

Entries are subject to any applicable restrictions or requirements listed herein. The Released Parties (as defined below) are not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, and other technological problems. The use of automated software or computer programs to register or enter the Sweepstakes is prohibited, and any individual who uses or attempts to use such methods to register or to enter will be disqualified. Incomplete and/or multiple entries will be disqualified. Should multiple users of the same email

participant and he/she must comply with these Official Rules. "Authorized account holder" is defined as the natural person who is assigned an email address or mobile phone number by an Internet access provider, online service provider, mobile service provider or other organization which is responsible for assigning email addresses, mobile phone numbers or the domain associated with the submitted email address. Valid entries must contain all information requested. Sweepstakes winner(s) will be selected from online entries only. Where applicable, one (1) prize per person/household. The Sponsor will not verify receipt of entries. By entering, participants acknowledge compliance with the Official Rules, including eligibility requirements. Responsibility for receipt of entry rests solely with the participant.

4. **PRIZE DRAWING / WINNER NOTIFICATION:** On or about one (1) weekday after the Sweepstakes End Date, one (1) potential winner will be selected in a random drawing conducted by the Sponsor from among all eligible entries received during the Promotion Entry Period. Odds of winning depend upon the number of eligible entries received during the Promotion Entry Period.

The potential winner(s) will be notified by the telephone, mail, and/or email provided at registration on or about one (1) weekday after winner selection and will be given three (3) calendar days to confirm receipt of notification. Notification is deemed to have occurred immediately upon placing of a telephone call or sending of an email or any other form of communication Sponsor may use to contact the finalist(s) (if any) and/or a potential winner. Sponsor is not responsible for any change of email address, mailing address, and/or telephone number of participants. The Sponsor is not obligated to leave a voice mail, answering machine, or other message. If a potential winner cannot be contacted from the information provided on the entry form, is disqualified, or deemed ineligible, the Sponsor reserves the right to select another winner at its sole discretion and if time permits (up to a maximum of three (3) alternate winner selections). The alternate potential winner will also be notified in accordance with this paragraph.

By participating, you agree (a) to be bound by these Official Rules; (b) as between you and the Sponsor, that the decisions of the Sponsor is final on all matters relating to the Sweepstakes; (c) you are not participating on behalf of any employer or third party; (d) in the event that you do not comply with these Official Rules, that you will be disqualified and your prize (if any) will be forfeited; and (e) (when applicable) the potential winner and/or finalist must be available to participate in any portion to the Sweepstakes that participation may be required to be considered eligible.

Potential winner(s) is subject to verification, including verification of eligibility. If a participant is unable to verify his/her information, the participant will automatically be disqualified and their prize, if any, will be forfeited. **The Sponsor reserves at its sole discretion the right to not award the prize or to determine an alternate winner or finalist (if applicable) in accordance with the Official Rules in the event that that any winner or finalist has been disqualified, cannot be contacted, or is deemed ineligible for any reason, or is not available to participate in any applicable Sweepstakes events.**

The potential winner(s) may collectively be referred to herein as "Winner" or "Winner(s)".

5. **PRIZE(S): ONE (1) PRIZE:** A three (3) day/two (2) night trip for Winner and one (1) guest (together, the "Attendees") to attend "Live on Tour: An Intimate Conversation with Michelle Obama" in Atlanta, Georgia scheduled to take place on May 11, 2019 (the "Event") (Approximate Retail Value ("ARV"): \$3,700.00). The trip includes:

- Round trip economy air transportation for the Attendees from the major airport nearest the Winner's residence to the major airport nearest Atlanta, GA (as determined by the Prize Provider in its sole discretion);
- Two (2) nights standard hotel accommodations (single room/double occupancy/room and tax only);
- Two (2) front-row tickets for the Attendees to the Event (exact seating as determined by the Prize Provider in its sole discretion);
- An opportunity for a photo (the "Photo Opportunity") for the Attendees with Michelle Obama.
- One (1) one hundred fifty dollar (\$150.00) pre-paid cash gift card (the "Promotional Card") to use toward ground transportation.

The total ARV of all prize(s) is \$3,700.00. Prize(s) provided by Prize Provider.

Winner(s) must complete and return an Affidavit (as defined below) before any prize will be awarded. Travel must take place between May 10, 2019 and May 12, 2019 and is based on Event availability, travel restrictions, and blackout dates. Any other dates are not valid. If a Winner is unavailable for travel by and/or on the designated date, the Winner will be disqualified and the Sponsor reserves the right to select another winner in its sole discretion and if time permits. Attendees will be required to pass U.S. Secret Service clearance which will include providing personal information to include complete legal name, address, place of employment, position, date of birth and social security number to participate in the Event prizing. Prize Provider reserves the right to revoke full or partial prize from any Winner or Winner's guest who it or venue personnel deem may, in its sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, or may bring Prize Provider into disrepute.
