- PROMOTION ENTRY PERIOD: Ryan Seacrest's Red Carpet Premiere Flyaway Sweepstakes (the "Sweepstakes") begins at 12:00:01 a.m. Eastern Time ("ET") on February 16, 2019 and ends at 11:59:59 p.m. ET on February 22, 2019 (the "Sweepstakes End Date") (collectively, the "Promotion Entry Period"). All entries must be received during the Promotion Entry Period. The Sponsor's (as defined below) computer is the official time keeping device for this Sweepstakes.
- 2. ELIGIBILITY: Sweepstakes is open to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are at least eighteen (18) years of age or older as of the date of entry.
