All Buddy Seats must comply with the following requirements:

- Driver and rider must be on the same plane (rider may not be higher or lower than driver).
- The seat may be for one (1) or two (2) riders only. No seat can hold more than two (2) riders.
- The seat must have handrails, a backrest and a seat belt or similar restraining device for each rider.
- The rider's feet may not dangle; there must be a foot rest.
- Seats may not be on the fender.

All drivers using a buddy seat must submit a photo of their FINISHED seat and have their buddy seat approved in advance of the 2025 ride. An approval of a buddy seat for a previous ride does not automatically transfer to the 2025 ride. **ALL BUDDY SEATS PHOTOS MUST BE SUBMITTED FOR APPROVAL NO LATER THAN MAY 2nd, 2025. IF YOU DO NOT RECEIVE APPROVAL OF YOUR BUDDY SEAT PRIOR TO THE RIDE, YOU WILL NOT BE ALLOWED TO USE THE BUDDY SEAT. RIDE MANAGEMENT RESERVES THE RIGHT TO REJECT ANY BUDDY SEAT.**
