

OFFICIAL RULES KIAK-FM FLY AWAY FRIDAYS CONTEST

The following contest rules have been designed in an effort to increase opportunities for more listeners to participate in iHeart Media contests and promotions. Certain requirements are deemed necessary for iHeart Media to stay compliant with Federal regulations.

(Revised March 13, 2009)

These rules apply to the FLY AWAY FRIDAYS at Gallo's Mexican Restaurant & Cantina CONTEST. Specific contests and promotions may have additional and/or substitute rules. If so, those rules may be picked up at the iHeart Media offices, 546 9TH Avenue, Fairbanks, during regular business hours, Monday-Friday, 8am-5pm.

- You can enter once each Friday between 4-6 pm during the dates of March 23, March 30, April 6 and April 13, 2018 at Gallo's Mexican Restaurant & Cantina. The winner will be randomly selected from the pool of all entries on Monday, April 16, 2018 and announced on-air on 102.5 KIAK-FM. Winner need not be present to win. Winning prize package is 1 Roundtrip Condor Airfare Voucher for 2 people @ approximately \$1000 and is not redeemable for cash. The winner of this ticket can use it for him/herself or pass it on to someone else but once booked and confirmed the ticket cannot be transferred. (Voucher dates valid June 7 to August 30, 2018).
- The prize pack is to be picked up at the iHeart Media offices, 546 9th Avenue, Fairbanks, during regular business hours, Monday-Friday, 8am-5pm. Prizes must be picked up within 10 (ten) working days, by the person who was awarded the prize. ALL WINNERS MUST PROVIDE A PICTURE ID, BIRTH DATE, AND CURRENT MAILING ADDRESS EACH TIME A PRIZE IS PICKED UP. Failure to provide any of the required information will result in forfeiture of the awarded prize. Winners will be solely responsible for any and all taxes incurred, local, state and federal, when accepting a prize.
- The winner will be required to complete a W-9 form in order to claim the prize. Only one completed W-9 form is necessary per year. iHeart Media is required to report all winners that accumulate \$600.00 or more in prize value winnings in one calendar year to the IRS.
